

# Kihívások, tapasztalatok - példák a résztvevők gyakorlatából

#### Challenges

- 1. funds are limited a lot of competition;
- 2. if you are not successful in one call this can lead to a break in contact with the other universities;
- 3. Little interest from staff to go to certain countries which are really interested in partnering up;
- 4. If there are not sufficient funds from Erasmus, there are some local funds which can be tapped in thus, competition between Erasmus and other funds;
- 5. Students from disadvantaged backgrounds can have added costs are, thus, further disadvantaged;
- 6. Funding cannot be shifted easily between country groups;
- 7. Some outgoing staff might find the period as too long disrupting their work;
- 8. The envelopes can be very hard to work with;
- 9. Partner universities might not cater for the courses offered at European Universities -how can we tackle this if the university is really interested in working with less developed countries;
- 10. Difficult to get the partners involved in the project difficult to establish the right contacts;
- 11. The criteria to choose partners should be better explained;
- 12. working with new partners is difficult as they are not familiar with the paper work involved, the programme and the European education systems;
- 13. Challenges with traineeships example with security conditions etc...;
- 14. difficulty when having different departments involved;
- 15. difficult to draft a coherent application;
- 16. different academic calendar in different countries difficult to slot in student mobilities;
- 17. Not realistic to increase the number of student mobilities to certain countries;
- 18. Start with staff mobilities in IRO;
- 19. Difficult to get feedback from the partner countries esp for final reports.

Although XXX may not have a specific growth strategy in terms of collaboration within Canada we consider collaboration with universities across Canada as very important part of our global engagement and overall international strategy. Malta has had long term relations with Canada mostly in view of the movement of Maltese migrants to Canada during the 1960s-1980s. These links have largely been retained over time and we occasionally receive students and visiting staff who are of Maltese descent and who return to Malta for a short period of study, teaching or research with the intention to also discover more about their roots. Extensive research has and continues to be conducted on aspects of this migration. Several members of the academic body at XXX have pursued their studies (particularly at Ph.D level) in Canada and

#### Canada award criteria edited

#### Relevance of the project/strategy

The extent to which the planned mobility project is relevant to the internationalisation strategy of the higher education institutions is not adequate and tenuous, and in fact largely absent:

'Although XXX may not have a specific growth strategy in terms of collaboration within Canada we consider collaboration with universities across Canada as very important part of our global engagement and overall international strategy.' Not even a slight explanation of this statement is attempted, or its elaboration and justification.'

Several other disconnected statements unfortunately do not in any way constitute a solid underpinning for showing the relevance of the project, for example making links with immigration and some previous research while Maltese students carried out their PhDs in Canada (but no link to the present or this relevance has been given):

'Malta has had long term relations with Canada mostly in view of the movement of Maltese migrants to Canada during the 1960s-1980s.'

'Several members of the academic body at XXX have pursued their studies (particularly at Ph.D. level) in Canada and there is joint research and several publications in a number of fields.'
