1. INTRODUCTION

This Guide contains additional information complementing the EEA Financial Mechanism 2009-2014 Scholarship Programme's (HU08) call for proposals.

2. GENERAL INFORMATION

About the implementation, background, organisational background and the targets of the Funds see the first chapter of General Application Guide (http://www.norvegalap.hu/en/palyazati-dokumentumok). Other parts of the Guide are not relevant to Scholarship Programme.

For Scholarship Programme, the present guide shall be applied.

2.1 Eligible Activities in the Framework of the Scholarship Programme

- Preparatory visits
- Mobility projects in higher education
 - Student mobility: study periods, practical placement, participation in summer university
 - Teacher, staff mobility: short teaching assignment, participation in conferences, seminars, workshops or other training events, job shadowing
- Teacher and staff mobility projects in other educational institutions / education related institutions
- Inter-institutional cooperation projects between higher education institutions
 - o Intensive Programmes
 - o Partnerships
 - Cooperation between higher education institutions and enterprises

Each measure (eligible activity) has a separate call for proposal and guide. This present guide is applicable for Inter-institutional cooperation projects between higher education institutions only.

2.2 Applicant Institution

Applications shall be submitted by Hungarian institutions holding an Erasmus Charter for Higher Education (ECHE).

2.3 Partner institutions

Hungarian, Donor States institutions and institutions from other Beneficiary States are eligible to participate in the programme as partner institutions.

2.4 Donor States

Norway, Iceland, Liechtenstein

2.5 Beneficiary States

Bulgaria, Croatia, Cyprus, Czech Republic, Estonia, Greece, Hungary, Latvia, Lithuania, Malta, Poland, Portugal, Romania, Slovakia, Slovenia, Spain

2.6 Donor Programme Partners

Agencies designated by the donor countries to contribute with their counsel to the preparation and implementation of the programme.

2.7 Special rules for enterprises

In case, in the framework of the application, a beneficiary is awarded aid for business objectives (this also includes for example the case when one of their employees is taking part in a training), the aid awarded to them is deemed as de minimis, which can be awarded exclusively in accordance with the regulations of articles 107 and 108 of the Treaty on the Functioning of the European Union, the Commission Regulation 1407/2013/EU of 18th December 2013 (HL L 352., 24.12.2013, p. 1) (hereinafter as Commission Regulation 1407/2013/EU) on the application of de minimis aid.

The aid amount awarded to an enterprise out of any resources with the legal title de minimis aid (with regard to three financial years) must not exceed the Hungarian Forint amount corresponding to 200,000 i.e. two-hundred thousand Euros, and the complete amount of the de minimis aid awarded to companies carrying out public road transport of commercial goods against consideration shall not exceed the Hungarian Forint amount corresponding to 100,000 Euros. This de minimis aid may not be used for the purchase of freight vehicles. When awarding each new de minimis (de minimis) aid, the complete amount of the de minimis aid awarded in the given financial year, as well as the previous two financial years, should be taken into consideration

With the exception of the provisions of paragraph (2) of article 1 of the Commission Regulation 1407/2013/EU, no enterprise may be beneficiary in case they would use the requested aid according to the exceptions specified in paragraph (1) of article 1 of the Commission Regulation 1407/2013/EU. The de minimis aid may not be accumulated with state aids regarding identical eligible expenses or identical measure of risk financing aim if the accumulation of the aid should exceed the maximum aid intensity or amount specified regarding the circumstances specified for each case in a group exemption regulation or a resolution adopted by the Commission. The beneficiary must save the documents related to the aid during 10 financial years after the awarding, and they must present these in case the supporter should call upon them to do so. At the request of the European Commission,

information must be provided about the aid granted under the legal title of de minimis aid within 20 working days.

3. FINANCIAL PROVISIONS

Every project can receive funding only once from the budget of the Scholarship Programme. Grants may not be awarded retrospectively for activities already completed at the time of the submission of the grant application. A grant may under no circumstances exceed the amount requested and may be below the amount requested by the applicant.

In case of *Intensive Programmes*, *Partnerships* and *Cooperation between higher education institutions and enterprises* the grant intensity is 90%. The remaining 10% should be covered by applicant and/or partner institutions.

The amount of the grant will be transferred in euro to the Project Promoter. The decision to award a grant is formalised through a Grant Agreement to be signed by the Project Promoter and Tempus Public Foundation, acting as the Programme Operator. The grant will be transferred to the beneficiaries directly by National Focal Point responsible for the implementation of EEA and Norway Financial Mechanisms 2009-2014.

3.1 Types of Financing

In case of grants are awarded as **lump sum**, reporting shall not be made on the actually emerged expenses but rather on the fact whether the activity has really been implemented. If the supported activity has been realized in a satisfactory way, then the project promoter shall receive the complete amount of the lump sum they are entitled. If it has not been implemented completely, then the applicant shall become entitled to a decreased grant amount, and also, in case a higher amount of grant has already been transferred than they are entitled, then they must pay back the grant or a part of it.

Grants are awarded as a **lump sum specified for days/months** (for example, when a maximum daily subsistence cost is specified), the project promoter has to be able to prove that the activity for which grant is awarded has really taken place (for example the number of days spent abroad determine the maximum amount of the grant), rather than the actual amount of expenditure.

In-kind contribution is also eligible as own contribution, in the form of voluntary working hours. For the calculation of the monetary value of voluntary work, § 2 of act 88 of 2005 should be used as a basis. 1 hour of work is the 1/160 part of the monthly minimum wage in accordance with the Hungarian legislation.

In case the **grant amount is (partially) based on actual expenses**, the Project Promoter must keep their invoices regarding the payment of actual expenses, and must be able to present them when requested.

3.2 Eligible expenses

a) In case of Intensive Programmes

• Subsistence cost

The amount of subsistence cost to be awarded for mobile students and teachers is a lump sum amount depending on the length of mobilities. Participants' scholarships are lump sum grants, which must be verified by the list of participants. The list shall contain the beginning and the end of participation, and it must be verified by the students' and teachers' signatures.

The maximum eligible amounts are included in the call for proposal. The expenses of non-mobile participants can be covered from organisational costs.

Travel cost

Travel cost is awarded as a lump sum amount. The amount depends both on the location of the IP and on the country of the participant's sending institution. The minimum 10 working days of the intensive course does not include travelling days; however, subsistence cost is awarded for these days provided that travelling is realized in the most cost-efficient way possible.

Organisational cost

All expenses, which emerge in connection with organisation of the IP. An applicant institution is entitled to the complete organisational cost when at least 10 students take part in the intensive programme that lasts at least 10 working days.

b) In case of **Partnerships** and **Cooperation between higher education** institutions and enterprises

The Hungarian institution submits the application as the coordinator of the project in the name of the participating partners. The agreement is signed by this institution and by the Programme Operator. On the basis of the partnership agreement concluded with the partners, the Project Promoter forwards to the partners the part of the grant amount the partners are entitled to. The applications shall contain detailed estimated budgets. The use and reporting of the grant occurs on the basis of actual costs with the exception of indirect costs.

The eligible costs are as follows: personnel costs, travel costs, subsistence costs, equipment costs, subcontracting costs, other costs (detailed below) and indirect costs. The correspondence between cost categories and ledger numbers is published in the annex of this Guide.

The eligible costs must meet the following general conditions:

- The costs must emerge at the institutions participating in the project.
- They are directly linked to the project, are indispensable for its implementation and for the adopted budget of the project; they have been planned in its modifications in effect (if applicable). The project budgets must contain sufficient detail, and be controllable so that the classification of the eligible costs can be determined.
- The unit prices serving as a basis for cost calculation shall not exceed the regular market price, and comply with the principles of cost-efficiency, economic viability and effectiveness.
- The legal basis (with the contract, contractor, public administration resolution etc.) and completion of expenses (with invoices, declarations and other valid accountancy or other internal receipts¹) having actually emerged at the Project Promoter and the partner institutions can be verified.
- Costs are only eligible to the extent they are related to the project and they contribute to its objectives.
- Co-financing is excluded regarding any cost of the project.
- Grant can be used exclusively to cover costs that can be supported in the framework of the given application and are not listed among non-eligible costs.
- During the implementation of the project, the non-used amount of the complete eligible budget shall decrease the grant amount proportionately according to the grant agreement. Any possible extra cost shall not be compensated, exceptions to these shall be the cases specified in §s 56 and 58 of the governmental decree 326/2012 (XI. 16)

- (hereinafter as implementation decree) on the implementation rules of the EEA and Norwegian Financial Mechanisms 2009-2014.
- Identifiable and controllable costs are eligible that are published in the accountancy registrations of the participating institutions separately and comply with the accountancy, tax and social security legislations.
- Exclusively those costs are eligible which have emerged between the beginning and closing dates of the accountability period. The emergence of a cost is deemed the date when the related task, service or transport is completed, and the issuing of the relevant receipt and the payment have been made. The emergence of depreciation related to the acquisition of equipment's is deemed the date when these costs have been fixed by the participating institution in their accountancy registration, in accordance with those specified in their accountancy policy.

3.2.1 Personnel costs

The following are applicable for all participating institutions of the project.

The following costs regarding personnel categories can be taken into consideration:

- Personnel having an individual employment contract concluded with one of the
 partner institutions for a definite or indefinite period, specified in the legislation. In
 order for someone to belong to this category, the appropriate partner institution should
 employ them.
- Persons employed by an external employment agency temporarily.

Costs related to personnel working at subcontractors should be listed in the category Subcontracting costs (see below). The participating institutions' employees may not work in their subcontractors' quality on a project.

The project budget should be determined on the basis of the actual daily personnel costs, in accordance with the organisation's regular practice regarding payments. Only those personnel types of expenses are eligible that are accounted according to the organisation's general remuneration regulations. Rewards, commissions and severance payments are not eligible.

Checks can be carried out to examine whether the expenses are real.

The actual daily personnel costs are based on average values according to the applicant institution's regular remuneration rules, and besides the actual wage, they also include social security contributions, other taxes and contributions related to wages and specified by the law. Costs that are not allowed according to the relevant regulations and legislation (especially, rewards, hired cars, financial incentives or profit-sharing systems) are not eligible.

The applicant institution shall define the number of days to be spent with project work in line with the activity and the work plan. The number of days spent with project work must be verifiable on the basis of work time registration.

Eligible personnel costs can be calculated as follows: the number of days multiplied by the actual daily personnel expenses.

The salary of civil servants, official staff, magistrates and others working in the state and public administration is only eligible in case it is related to the project activities and not to the employee's legal duties and regular employment tasks.

3.2.2 Travel costs

Travel costs are only eligible on the basis of the actually emerged costs.

The travel costs of colleagues participating in the project are eligible if it is in accordance with the regular practice of the given partner regarding travels on duty.

Only those travel costs are eligible that are connected to specific and clearly identifiable activities of the project. For the travel costs of people not belonging to the personnel, see sections Other costs and Subcontracting costs.

Travel costs include all the means of transport and all the expenses emerging from the starting point to the destination (and back), and can also cover the fees of visa, travel insurance and those related to the cancellation of the travel.

Costs are based on actual expenses, independently of the means of transport chosen (railway, bus, cab, airplane, hired car). Participants shall use the most cost-efficient way of travelling (e.g. they should buy second-class/tourist class tickets, in other cases they should be able to provide detailed explanation for the justification of these).

The costs of travelling by a privately owned car (owned by a private entity or a company), in case they are justified and the price is not too high, may be repaid as follows (the cheapest way should be selected):

- either by kilometre-based cost accountancy in accordance with the organisation's internal regulations, up to the amount of a maximum of 0.22 EUR/km.
- or on the basis of the price of a railway, bus or airplane ticket (see above). Independently of the number of people travelling in one vehicle, only one ticket can be paid for.

In case of hired cars (vehicles not over category B or corresponding to that) or cabs: the actual costs are eligible in case they are not too high compared to other means of transport (also taking into consideration other influencing factors, e.g. time, too much luggage because of the nature of the project etc.). Cost compensation occurs independently of the number of people travelling in one vehicle.

3.2.3 Subsistence costs

In the framework of multilateral projects, the subsistence costs of a colleague travelling to another participating country are considered as eligible costs.

Costs of only those travels are eligible that are connected to specific and clearly identifiable activities of the project. For the payment of subsistence costs of people not belonging to the personnel, see sections Other costs and Subcontracting costs.

The compensation of these costs follows the partner organisations' valid internal regulation, and it can occur based on actual expenses (paid invoices) or on daily allowance. In both cases, evidence is required to prove the presence of the person and their accommodation so that these costs can be supported in the accountancy period.

Subsistence costs cover accommodation, meals and local transport at the destination abroad (but they do not include the costs of local transport from the starting point to the destination). To determine the number of days to which daily allowance should be applied, please note that a COMPLETE day usually includes accommodation. In duly justified cases, daily allowance can also be paid without overnight accommodation; in this case the amount should be decreased (limited to 50 % of the maximum amount).

The amounts should be decreased proportionately in case a third party provides accommodation, meals and local transport.

3.2.4 Equipment costs

The purchase, hiring or leasing of (new or second-hand) equipment, including the costs of installation, maintenance and insurance, are eligible with the following conditions:

- Exclusively, if it is necessary and specific for the objectives of the project/activity. The requested cost of equipment's shall be duly justified and certified properly. The rules regarding procurement should be applied (see below, Subcontracting costs section).
- In case of a purchase, if depreciation is described by the generally accepted taxation law and accountancy rules applicable for the project promoter / partner consortium.

Regarding equipment, only the depreciation part falling on the period of the activity and the actual proportion of use in accordance with the objectives of the activity can be taken into consideration. In case the nature of the tool and/or the circumstances of its use should require different assessment, then this should be certified properly.

All equipment related to the management of the project (PCs, data carrying computers etc.) and equipment acquired before the starting of the project can only be accounted as indirect costs.

The total cost of the tools may not exceed 10 % of the project's total eligible costs.

3.2.5 Subcontracting costs

Emerging costs serving the implementation of a part of the activity related to contracts concluded with third parties are eligible in case a participating institution concludes a contract with an external body, organisation or private entity (in case they are not employed by any partner institution of the consortium either). For example translation, interpreting and printing belong here.

In order to maintain the principle of project partnership, the management and general administration of the project cannot be subcontracted.

If the Project Promoter is deemed as contracting authority in accordance with the act on public procurement, and in case the amount of the awarded grant is over 50 % of the eligible costs then procurements related to the implementation of the project shall be executed by Project Promoter in accordance with the provisions of the act on public procurement.

Regarding procurements executed in accordance with the provisions of the act on public procurement, the Project Promoter must ensure the inspection of the procurement procedure in accordance with the provisions detailed in §s 73 to 79 of the Implementation decree, the detailed rules of which are included in a separate procedural regulation.

In case the Project Promoter should not be deemed as a contracting authority, also if the procurement should not reach the public procurement value limit then the Project Promoter must proceed in accordance with their own procurement regulations, taking into consideration the principles of economic viability, cost efficiency and transparency. In case of procurements over 1 million Hungarian Forints value, the correspondence with the market price is to be justified on the basis of quotations provided by at least 3 comparable contractors capable of performing the task.

An enterprise cannot participate in the implementation of the supported project that has been selected in a public procurement or other procedure if its owner, member, senior executive, member of the Supervisory Board/Board of Trustees or employee is

- a) in employment relationship or any further legal relationship directed at work performance with the Project Promoter,
- b) senior executive of the Project Promoter organisation, member of the Supervisory Board/Board of Trustees,
- c) member of the Project Promoter,
- d) having direct or indirect ownership shares in the Project Promoter,
- e) having participated in the preparation or execution of the procurement procedure in any way.

or a close relative of the entities according to sections a) to e), according to section b) of § 685 of act 4 of 1959 on the Civil Code (hereinafter as the Civil Code).

The total cost of the subcontract may not be more than 30 % of the total direct eligible costs of the project.

3.2.6 Other costs

Other costs are determined on the basis of the actual costs.

In the category of other costs, only other costs not mentioned above are eligible, having emerged at the participating institutions, in direct connection with the project. Only those special activities can be taken into consideration that are explicitly required in order to reach the objectives of the project/activity. Costs shall always be justified in an appropriate way.

Direct costs emerging in the following way are eligible:

- costs stemming from duties specified by the grant agreement (distribution of information, independent evaluation of the activity, banking expenses), including the costs of any other possible financial services (e.g. financial guarantees),
- dissemination and communicational costs, that is e.g. organisation of seminars, (in
 case the seminar has also been a product/result planned in advance, and the costs
 related to the task are easy to identify with press releases and publications that
 costs occurred once
- buying copyrights and other intellectual property rights,
- buying informational materials (books, studies and electronic data),
- costs of conferences; cost of registration for conferences; renting an exposition booth etc.

All the costs emerging in the framework of the subcontract should be indicated under subcontracting costs category.

In case of compensation of the travel costs and/or subsistence costs of third parties (e.g. costs of people who are not employed neither by the partners of the consortium nor by the subcontractors) then reimbursement rules regarding the partners' employees shall be applied. All the costs related to the project's administration, (i.e. consumable items, office materials, costs of photocopying, phone expenses, paper etc.) are considered as the project's indirect costs.

3.2.7 Eligible indirect costs

The way of calculation of indirect costs eligible in the framework of the project for one year is the following:

The percentage of the total budget of the application compared to the valid complete annual budget of the applicant institution when submitting the application. This percentage determines percentage eligible from the institution's indirect costs (from their general company expenses) planned for the given year (in the case of not complete years, providing the proportion for the given period). In case the annual budget has not been approved when submitting the application, then the basis for the calculation of the eligible percentage should be the annual budget plan approved last time in the previous year or the statement of the previous closed year. This method should be applied for each participant if indirect costs are to be accounted. Costs that cannot be identified as directly related to the implementation of the activity (taking into consideration the eligibility conditions explained above) and that emerge in connection with the implementation of the project are considered as eligible indirect costs. No eligible direct costs can be included among these costs.

Eligible indirect costs are awarded as lump sum that cannot exceed 15 % of the eligible direct costs. The subcontracting costs and expenses of resources not applied in the Project Promoter's premises are not eligible direct costs. Costs are not required to be justified by accountancy receipts but registrations should be managed in accordance with the legislative and internal regulations.

Examples of indirect costs:

• communication costs (mail cost, fax, phone, correspondence etc.)

- overhead costs of the establishments serving as locations for the project's implementation (real estate rental fee, electricity invoice etc.)
- office materials
- photocopies.

3.2.8 Not eligible costs

All costs that are not included among eligible costs, especially the following:

- Return on investment;
- Credit interest, tax burdens, default interest;
- Costs of financial transactions and other costs of pure financial nature, except for the costs of bank accounts separated for the project, as well as the costs of financial guarantee provided by the financial institution in case it is required in the grant agreement;
- Reserve for possible losses;
- Reclaimable VAT:
- Expenses that are financed from other grant resources;
- Fine, penalty, legal expenses;
- Expenditures of excessive amounts or incompatible with economic rationality.
- Costs related to the preparation of the application to be submitted;
- Costs emerging in connection with any document required to be submitted with the application;
- Costs falling beyond the period of use of the grant;
- Gift:
- Costs in the case of which the invoices and receipts have not been issued to the name of the Project Promoter (or any project partner) are not eligible.

3.3 Co-financing

The applicant must declare (see sections 4.4.4.3 and 4.4.15.3) whether they have applied previously or parallelly with this application for another grant for the project described in the proposal. If yes they should precise in what form and provide the necessary data for identification. The applicant acknowledges that similar or identical projects are subject to special treatment in order to exclude co-financing, furthermore Programme Operator does not support similar or identical proposals.

4. ABOUT THE ACTION AND APPLICATION FORM

4.1 Inter-institutional Cooperation Projects between Higher Education Institutions action

Application shall be submitted by Hungarian institutions holding and Erasmus Charter for Higher Education. The cooperation of at least three institutions can be supported where one of the institutions shall be from Hungary and one of them from a Donor State. Other partners can be institutions from Donor States, Hungary or from other Beneficiary States.

The following activities can be supported within the framework of this action: intensive programmes, partnerships and cooperation projects between higher education institutions and enterprises. The description of each subtype is included in the call for proposal. Further examples are listed below.

a) Intensive Programmes:

Short programmes of study organised in different interdisciplinary topics.

b) Partnerships

Development, testing, adaption of curriculum or part of curriculum; preparation of international joint trainings and related curriculum development; development of the quality of practical placements; harmonisation of study programmes (e.g. short cycle study programme in higher education); preparation of competence lists related to a given profession prepared by several countries; approximation of higher education trainings and labour market needs via exchanges of experiences, research studies, surveys; promotion of existing international trainings that are not supported from other resources; preparation of a sustainability strategy; involvement of company and business resources.

c) Cooperation Projects between Higher Education Institutions and Enterprises Elaboration of new teaching and learning methods; development of innovative trainings; strengthening entrepreneurship; approximation of higher education and labour market.

4.2 Accessing the applicants' area

Applications for the *Scholarship Programme* operating within the framework of EEA shall be submitted via the online submission database.

To submit an application, the applicant must register first at the official website of the Funds (www.egtalap.hu or www.norvegalap.hu) in order to gain access to the applicants' area https://nora.norvegalap.hu/. Afterwards, the online application form needs to be filled in and the necessary documents should be uploaded. After having submitted the application, the official declaration of the applicant should be signed, too (see 4.3.6.1 or 4.4.15.1 Official Declaration of the Applicant).

4.3 Language of the application form

The application form is bilingual, all the necessary documents (forms, call for proposals guides) are available in English and in Hungarian, too. The application form in the appropriate language can be reached by clicking on the buttons (magyar / English) in the top right corner.

MAGYAR / ENGLISH

Application form shall be filled in English, since the application shall be based on the common work and consent of the participating partner institutions. It is important that every partner institution participating in the project understand the objectives of the project, agree with them and be determined about the project's successful implementation and undertaken results.

4.4 Filling in the application form
