

STATEMENT FOR APPLICATION for Hungarian State Scholarships – summer university courses

By clicking on the “I accept” button, I agree to the followings.

I agree and understand that the Sending Partner, Tempus Public Foundation; the ministry who provides the financial support of the scholarships, and the higher education institutions that the applicant applied to may collect, process and use **my personal data** submitted as part of the application and enrolment process. The data is collected, processed and used for purposes of checking the eligibility for participation in the programme; follow up, reporting and financial monitoring; the preparation of statistics, informational materials, surveys and research. My personal data can be stored and handled for 10 years. Data can be handled by the relevant employees of the Tempus Public Foundation and the higher education institution, participants of the reporting and monitoring processes; authorities responsible for supervision and inspection; anonymous experts and researchers analysing the implementation and the impact of the programme. All safety measures shall be done in order to ensure data protection with special regard against unauthorized access, modification, forwarding, publication, deletion or destroy, as well as incidental destruction and damage.

I understand that the Hungarian State scholarship is the participation fee which includes the classes, accommodation and meals, therefore – within the framework of the programme – visa-related assistance, additional allowance and administrative services are not provided for any accompanying people or family members.

I agree and understand that once I am a Scholarship Holder I will be expected to **follow the regulations of the Host Institution** and continue my studies in good faith, to the best of my abilities, in order to meet the academic requirements of the study programme and thus finish the programme successfully. If I am selected to be Scholarship Holder I agree to participate in the alumni system of the programme that supports the maintenance of relationships with the Scholarship Holders and facilitates the flow of information – such as the alumni website, alumni events and surveys about the satisfaction of students, career monitoring and the evaluation of research activities.

I agree and understand that once I am a scholarship holder, I am **obliged to stay in Hungary during the entire period of my studies**.

I agree and understand that in case of receiving any other Hungarian–state or EU–financed scholarships for the same purpose and/or time period, I’m not eligible for the Hungarian State Scholarship. In case that I am awarded more than one scholarship, I shall choose one of the scholarships and renounce from the other ones.

I agree and understand that **in accordance with the Operational Regulations of the programme, the scholarship status is terminated if**

- the scholarship holder withdraws from the scholarship in a written form (sent to both Tempus Public Foundation and the Host Institution),

- the scholarship holder receives Hungarian citizenship (except those with dual citizenships), granted a refugee status (“menekült), temporary protection (“menekültes”), or admitted for subsidiary protection (“oltalmazott”) or granted humanitarian protection (“befogadott”),
- the scholarship holder is convicted as a result of institutional disciplinary or criminal proceedings
- in other cases described in the Operational Regulations of the programme in effect.

I agree and understand that in case I will be awarded the Hungarian State scholarship, and following the acceptance of the scholarship I do not travel to Hungary and start my studies, nor do I notify Tempus Public Foundation of this fact, I will not be eligible to reapply for Hungarian State scholarship within three years from being awarded.

I agree and understand that applicants who are awarded the scholarship cannot get a scholarship holder status if they

- withdraw the scholarship in a written form (sent to both Tempus Public Foundation and the Host Institution) or in the application system,
- do not upload their missing application documents until the deadline given in the Call for Applications,
- do not arrive and enrol until the registration date specified by the Host Institution (except cases described in the Operational Regulations).

I agree and understand that all scholarship holders are bound by the Operational Regulations of the Hungarian State Scholarship Programme.

I hereby confirm that I am not a Hungarian citizen. (Except those with dual citizenships)

I understand that the scholarship can be awarded to only those who were born before 30 March 2005.

I confirm that I have read, understood and agree to the content of this statement and the above procedures related to my participation in the Hungarian State Scholarship Programme.

I confirm that all information I provided as part of the application and enrolment process is, to the best of my knowledge, accurate and true. I also declare that all information provided by me on the online application surface of Tempus Public Foundation – including the content of all uploaded documents – are true and correct to the best of my knowledge and belief. I am fully aware that false statements will disqualify me from the scholarship programme.
